Reeve is a court-recognized expert on animal fighting in both state and federal courts. She has trained over 6,500 law enforcement officers in animal fighting investigations, including the FBI Behavior Analysis Unit and the International Law Enforcement Attachés Association, throughout the United States, Costa Rica, Virgin Islands, Puerto Rico, Guam, Mexico, Guatemala, Romania, and Australia. Reeve has appeared in numerous media pieces, coauthored several publications about dogfighting, and building cases with federal law enforcement.
