

# LBVM Report of its Review of Rules Mandated by JML Executive Order No. 25-038

The Louisiana Board of Veterinary Medicine (“LBVM” or “Board”) submits this report to the Office of the Governor, the Senate and House Legislative Oversight Committees on Agriculture, Forestry, Aquaculture, and Rural Development concerning the review mandated by JML Executive Order No. 25-038.

The Executive Order mandated that the Board examine at least 50% of the rules listed below by December 31, 2025, with the remaining rules being reviewed by December 31, 2026. The Board is to determine whether the rule is necessary, consistent with the law, and aligned with the board’s mission, and assess whether the benefits of the rule outweighed the burdens and costs on those regulated by it.

In accordance with such executive order and statute, the LBVM has examined each of the rules listed below on the dates and in the manner described hereafter, after which the LBVM decided to amend, repromulgate, or repeal as noted hereafter. These rules as amended or repromulgated are essential and directly align with the mission of the Louisiana Board of Veterinary Medicine to protect and promote public health, safety and welfare of animal patients and the people of Louisiana.

## Amended Rules – Rulemaking Process Underway

The LBVM evaluated the rules listed below as mandated by JML Executive Order No. 25-038 to determine whether each is necessary, consistent with the law, and aligned with the board’s mission. The Board further assessed whether the benefits of the rule outweigh the burdens and costs on those regulated by it. After conducting this examination, the Board determined that the following rules should be amended and, as amended, will satisfy the criteria of JML Executive Order No. 25-038.

On August 5, 2025, the LBVM voted to amend the following rules with respect to the renewal of licenses and certificates. The proposed rule amendment clarifies guidelines regarding continuing education and late fees for veterinarians who fail to renew their license. **The rulemaking process to amend these rules began on September 5, 2025.** No public comments or petitions for a public hearing were received by the Board.

Rules §§ 305, 407, 811, and 1213

## **Amended Rules – Rulemaking Process Completed**

The LBVM evaluated the rules listed below as mandated by JML Executive Order No. 25-038 to determine whether each is necessary, consistent with the law, and aligned with the board’s mission. The Board further assessed whether the benefits of the rule outweigh the burdens and costs on those regulated by it. After conducting this examination, the Board determined that the following rules should be amended and, as amended, will satisfy the criteria of JML Executive Order No. 25-038.

On April 4, 2024, the Board discussed and voted to amend the following rules regarding the display of degrees, the conduct of one’s practice, means of advertising, and the protection of patient/client confidentiality related to social media posts. Of greater substance was the amendment in section 1039 related to a veterinarian’s receipt of client consent in non-emergency situations. In a non-emergency situation where circumstances render it impossible to have the owner or duly authorized agent execute the written anesthesia consent form prior to the administration of anesthesia, oral consent may be obtained from the owner or authorized agent, in which case the oral consent shall be witnessed by one person and documented in the patient’s medical record. All other proposed amendments made rule language more uniform and consistent. Rulemaking began on May 8, 2024, and no public comments or petitions for a public hearing were received by the Board. **The Final Rule was promulgated into the *Louisiana Register*, volume 50 on November 20, 2024.**

Rules §§ 1007, 1011, 1051, 1057, and 1063

On February 1, 2024, the Board discussed and voted to amend the following rules to better define an unlicensed veterinarian, to require an in-person physical examination to establish the Veterinarian-Client-Patient-Relationship, and to give discretion to the licensed veterinarian with respect to the allowable drugs prescribed and dispensed to Louisiana deer farmers. Rulemaking began on July 18, 2024, and **the Final Rule was promulgated into the *Louisiana Register*, volume 51 on February 20, 2025.**

## **Repromulgated Rules - Criteria of JML 25-038 and Act 192 are Satisfied, Repromulgated with No Amendments**

On October 2, 2025, the Board evaluated the rules listed below and determined that the rules are necessary and consistent with the law and are to be maintained without amendment or change. **The Final Rule was promulgated into the *Louisiana Register*, volume 51 on November 20, 2025.**

## **Repealed Rules – In process and Completed**

On August 5, 2025, the LBVM evaluated the rule listed below and determined that it could be repealed and the language and intent merged into another section. **The rulemaking process to repeal this rule began on September 5, 2025**, and no public comments or petitions for a public hearing were received by the Board.
